INTRODUCTION

The specialty of **General Comprehensive Dentistry** arises as a need of the National Health System of Cuba focused on the Primary Care Model, to achieve the solution of the problems of the community, the family and the individual with a biological and social approach.

The General Comprehensive Dentistry (GCD) specialist is a new Cuban conception and is equivalent as Family Dentistry abroad; GCD is a professional with a broad profile prepared to guarantee comprehensive dental care with restorative and rehabilitative treatment actions combined with actions to promote health, disease prevention and rehabilitation in a continuous and systematic way, together with the rest of the health team, of which is a crucial part, and whose purpose is to increase the level of a defined population's health.

MODEL OF THE SPECIALIST

Professional characterization

The specialist of first degree in comprehensive general dentistry is responsible for the oral cavity health of individuals, family and community, with a social approach, which should be characterized by his responsibility, simplicity, modesty, integrity and human condition, that all health professional must possess.

The specialist should be prepared scientific and technically to approach the problems of the oral cavity component, maintaining a responsible attitude towards a permanent betterment.

The comprehensive general dentistry specialist constitutes the fundamental link of the dental attention since he develops his professional practice in the primary level of health, connected in a direct way to the family doctor and the rest of the dental specialties and sectors of the community.

PROFESSIONAL PROFILE

COMPREHENSIVE DENTAL CARE FUNCTION

-To carry out the analysis of the health situation with oral cavity component on the assigned population.

-To carry out actions of health on the population he assists in order to: promote, prevent, diagnose, dispense, treat, rehabilitate, remit and share views from a clinical and social perspective.

-To establish an intra and inter sectorial nexus in the community with the purpose of the analysis of the health situation.

-To carry out urgency attention before different problems of health and scenarios.

TEACHING FUNCTION

-To identify learning necessities, in his population or among professionals and technicians, or other workers that form the health team with the objective of elaborating teaching processes.

—To plan, direct and control teaching processes related with topics of his specialty.

—To participate in educational processes of pre and postgraduate degree, in technical and professional careers related with his profile.

MAJOR SKILLS AND COMPETENCES:

- To prepare activities for health promotion, prevention, opportune diagnosis and effective treatment of dental diseases in the Primary Health Care.
- To establish the positive and differential diagnosis of dental diseases, taking into account the data obtained in the interview, the physical examination and the diagnosis of complications.
- To guide team work among different specialties.
- To treat periodontal diseases in the Primary Dentistry Care.
- To diagnose and to treat dental diseases that mainly affect children.
- To diagnose and to treat dental trauma.
- To diagnose and to treat malocclusions in the Primary Dentistry Care.
- To diagnose and to treat toothless masticatory dysfunction in the Primary Dentistry Care.
- Carry out endodontic treatment of monoradicular and multi radicular teeth in adults and children.Surgical treatments in the Primary Dentistry Care.
- Ordering and interpreting extra and intraoral x-rays.
- Treating buccal diseases with Traditional and Natural Medicine (acupuncture, phytotherapy and apitherapy).
- Treating buccal diseases in patients suffering from systemic diseases.
- Treatment to conventional and non-conventional handicapped patients (under general anesthesia, adults and children)
- To give psychological support to patients in the self-care process to preserve a healthy lifestyle.
- Elaborating and applying techniques and procedures for scientific research.

EVALUATION SYSTEM

- FORMATIVE EVALUATION: It is a monthly evaluation, registered on the resident's evaluation card, in accordance with the requirements of the program. It includes the results of teaching activities, attendance, and participation in courses, case discussions and rotations planned in the Program.
- PROMOTION EVALUATION: at the end of each academic period of residency. There are two components evaluated by the Academic Board appointed by the Rector of the University:
 - A practical examination.
 - A theoretical examination.

Requirements: To qualify for this examination, the resident must have complied with the schedule of the research protocol called the Research Work of Completion of the Specialty, as endorsed by the tutors.

Score distribution for the year promotion evaluation:

- o Course evaluation: 30 points (minimum 21 points)
- Theoretical exam: 30 points (minimum 21 points)
- Practical exam: 30 points (minimum 21 points)
- Research Work of Completion of the Specialty: 10 points (minimum 7 points)

To be considered approved, it is needed to obtain the 70% of points each year.

- GRADUATION EVALUATION: It is done at the end of the second year of residence. It has three components evaluated by the Academic Board appointed by the Rector of the University on behalf of the State:
 - Research Work of Completion of the Specialty presentation and discussion.
 - Practical examination.
 - Theoretical examination.
